After carefully reading the following Rules and Regulations, please <u>SIGN</u> and <u>RETURN</u> a copy with your signed <u>RENTAL CONTRACT</u>.

- 1. CHECK-IN TIME is after 3 PM EST
- 2. CHECK OUT TIME is 11 AM EST
- 3. This is a non-smoking unit.
- 4. We will not rent to vacationing students or singles under 24 years of age unless accompanied by an adult Or parent.
- 5. DAMAGE/RESERVATION DEPOSIT A damage/reservation deposit of \$200 is required. This must be received within seven (7) days of booking the reservation. The deposit automatically converts to a security/damage deposit upon your arrival. The deposit is NOT applied toward rent; however, it is fully refundable within fourteen (14) days of your departure provided the following provisions are met:
 - A. No damage is done to the unit or its contents, beyond normal wear and tear.
 - B. No charges are incurred due to pets or collection of rents or services rendered during your stay.
 - C. All debris, rubbish and discards are to be bagged and placed in outside covered trash cans; soiled dishes are to be placed in the dishwasher and dishwasher started; all bed linens should be stripped from the beds and other soiled linens both from the bath and kitchen should be placed in the laundry room.
